## **Target market summary**

This product is intended for use as a satellite, minor or core allocation to global equities for a consumer who is seeking capital growth and has a very high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 5 years or more, and who needs to withdraw their money on less than one week's notice.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

### **Appropriateness**

### Investment products and diversification

Issuers should consider both the frequency for accepting the request and the length of time to accept, process and distribute the proceeds of such a request. To the extent that the liquidity of the underlying investments or possible liquidity constraints (e.g. ability to stagger or delay redemptions) could impact this, this is to be taken into consideration in aligning the product to the consumer's need to access capital. Where a product is held on investment platforms, distributors also need to factor in the length of time platforms take to process requests for redemption for underlying investments. Where access to investment proceeds from the product is likely to occur through a secondary market, the liquidity of the market for the product should be considered.		
Distributor reporting			
	Section 994F(6) of the Act requires distributors to notify the issuer if they become aware of a significant dealing in the product that is not consistent with the TMD. Neither the Act nor ASIC defines when a dealing is 'significant' and distributors have discretion to apply its ordinary meaning.		
	The issuer will rely on notifications of significant dealings to monitor and review the product, this TMD, and its distribution strategy, and to meet its own obligation to report significant dealings to ASIC.  Dealings outside this TMD may be significant because:		
	<ul> <li>they represent a material proportion of the overall distribution conduct carried out by the distributor in relation to the product, or</li> <li>they constitute an individual transaction which has resulted in, or will or is likely to result in, significant detriment to the consumer (or class of consumer).</li> </ul>		
Significant dealings	In each case, the distributor should have regard to:		
	<ul> <li>the nature and risk profile of the product (which may be indicated by the product's risk rating or withdrawal timeframes),</li> <li>the actual or potential harm to a consumer (which may be indicated by the value of the consumer's investment, their intended product use or their ability to bear loss), and</li> </ul>		
	• the nature and extent of the inconsistency of distribution with the TMD (which may be indicated by the number of red ratings attributed to the consumer).		
	Objectively, a distributor may consider a dealing (or group of dealings) outside the TMD to be significant if:		
	<ul> <li>it constitutes more than half of the distributor's total retail product distribution conduct in relation to the product over the reporting quarter,</li> <li>the consumer's intended product use is solution / standalone,</li> <li>the consumer's intended product use is core component or higher and the consumer's risk and return profile is low, or</li> <li>the relevant product has a green rating for consumers seeking extremely high risk/return.</li> </ul>
