Target Market Summary

This product is intended for use as a standalone to satellite allocation for a consumer who is seeking capital growth and income from a diversified balanced portfolio of growth and income generating assets and has a *medium to high* risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 4 years or more, and who needs to withdraw their money on less than one week's notice.
