Role Summary

Due to an expansion in the business, an opportunity has arisen in the operations team. We are seeking a bright, enthusiastic and motivated person to join the investment operations team in a dynamic, growing business.

The successful candidate will work closely with portfolio management, back office administration teams and external service providers. To support this role, you will ideally have experience across unit pricing, fund accounting and distributions.

Responsibilities

Your duties will include but will not be limited to;

- Developing an in-depth understanding of the operational processes supporting the BetaShares business.
- Reconciliation of the NAV (security valuations, fee accruals, receivables and liabilities) and oversight of timely and accurate NAV calculations on a daily basis.
- Reviewing prices against benchmarks and expected returns and follow up of any exceptions.
- Producing and monitoring fund reporting including month-end reporting and disclosure requirements.
- Review of Corporate Actions and impacts to the NAV.
- Reviewing distribution calculations and tax (ATO BAS/IAS).
- Reviewing financial statements in the validation of fund activity.
- Reporting weekly/monthly/quarterly funds under management and performance reports for internal stakeholders, senior management and research houses.
- Updating of the daily procedures, workflows and management of initiatives to continue to improve and develop control functions.
- Maintaining the accuracy of written procedures and processes.
- Ensuring all reporting meet compliance requirements and monitoring compliance reports as required.
- Supporting trade operations and other operational tasks as required (trade support, security maintenance, corporate action instructions and management, confirmation and settlement issues, cash flow management, ETF creations and redemptions).
- Utilising systems including the portfolio management system.
- Supporting adhoc projects and be available to respond to queries from portfolio management, Finance and other BetaShares teams.
- Acting as a liaison point with various outsourced service providers including the custodian, fund administrator, share registrar and system vendors.
- Participating in the verification and implementation of new systems and processes as the business grows.
- Deploying operational improvements that propel our wider risk management efforts.

The successful candidate will have:

- Minimum of 3-5 years of relevant experience in a fund accounting or financial services role in managed funds.
- Tertiary qualified in an Accounting or Finance (CPA/CA not essential) or other relevant education.
- Required work schedule on an AM/PM rotational basis (across 8.00am-7.00pm) or as required. Flexibility supported to work remotely outside of ordinary hours.
- Proven ability to liaise with Senior Management in understanding business requirements.
- Established experience as a practiced user in portfolio administration software. Bloomberg's experience is helpful.
- Strong attention to detail.
- Demonstrated ability to resolve complicated issues and to advance multifaceted initiatives.
- Excellent verbal and written communication as there is a requirement to liaise with internal and external parties.
- Strong data analysis and excel skills.
- Self-starting initiative.
