### Target market summary

This product is intended for use as a satellite or minor allocation to equities within a portfolio for a consumer who is seeking capital growth, and has a high or very high risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 5 years or more, and who needs to withdraw their money on less than one week's notice.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

## Investment products and diversification
