## Target market summary

This product is likely to be appropriate for a consumer seeking capital growth by providing exposure to 100 of the largest non-financial companies listed on the Nasdaq stock market, based on market capitalisation, hedged into Australian dollars, to be used as a core allocation to global equities, or a tactical exposure to the global technology sector, within a portfolio where the consumer has a medium to long investment timeframe (5+ years), very high risk/return profile and needs daily access to capital.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

### Instructions

## Investment products and diversification

For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. The FSC recommends adoption of the Standard Risk Measure (SRM) to calculate the likely number of negative annual returns over a 20 year period, using the guidance and methodology outlined in the <b>Standard Risk Measure Guidance Paper For Trustees</b>. SRM is not a complete assessment of risk and potential loss. For example, it does not detail important issues such as the potential size of a negative return or that a positive return could still be less than a consumer requires to meet their investment objectives/needs.
