Target market summary

The product is likely to be appropriate for a consumer seeking capital growth by providing exposure to crude oil futures, hedged into Australian dollars, to be used as a small allocation, where the consumer has a short investment timeframe, very high risk/return profile and needs daily access to capital.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

In the tables below, Column 1, Consumer Attributes, indicates a description of the likely objectives, financial situation and needs of the class of consumers that are considering this product. Column 2, TMD indicator, indicates whether a consumer meeting the attribute in column 1 is likely to be in the target market for this product.

Generally, a consumer is unlikely to be in the target market for the product if:

Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (typically with an intended product use of satellite/small allocation or core component). In such circumstances, the product should be assessed against the consumer's attributes for the relevant portion of the portfolio, rather than the consumer's portfolio as a whole. For example, a consumer may seek to construct a conservative portfolio with a satellite/small allocation to growth assets. In this case, it may be likely that a product with a High or Very High risk/return profile is consistent with the consumer's objectives for that allocation notwithstanding that the risk/return profile of the consumer as a whole is Low or Medium. In making this assessment, distributors should consider all features of a product (including its key attributes).

If the outcome from rolling futures tracts is consistently negative during a period then, all else being equal, the performance of the Fund will be than the performance of the spot price of crude oil over the same period. The yield from rolling futures contra may in other circumstances be positive, which would enhance the Fund's returns, all else being equal. The Fund itself has low portfolio diversification.
