#### **Target market summary**

This product is intended for use as a satellite, minor or core allocation within a portfolio for a consumer who is seeking capital growth or capital preservation (depending on the consumer's purpose) and regular income and has a medium risk and return profile for that portion of their investment portfolio. It is likely to be consistent with the financial situation and needs of a consumer with a minimum investment timeframe of 3 years or more, and who needs to withdraw their money on less than one week's notice.

The Fund is an exchange-traded product and is generally only available to consumers through the ASX.

#### **Appropriateness**

#### Investment products and diversification

A consumer (or class of consumer) may intend to hold a product as part of a diversified portfolio (for example, with an intended product use of minor allocation).
