## **Responsible Investment Committee**

The Responsible Investment Committee ("RI Committee") is a body, established by the Responsible Entity, that is nominated in the Nasdaq Future Global Sustainability Leaders Currency Hedged AUD Index methodology (which Betashares Global Sustainability Leaders ETF – Currency Hedged aims to track) to determine the list of index securities that pass the ESG-related screens and meet the Climate Leaders criteria as set out in the methodology.

The RI Committee comprises individuals, appointed by Betashares, who are advocates of, and have experience and expertise in, ethical investing. A representative of Betashares is a member of the RI Committee, with a majority of members comprising other industry experts. The RI Committee's determinations are made by majority vote.
