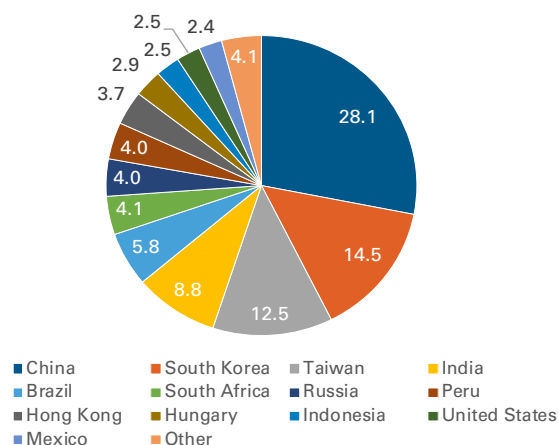
FIVE REASONS TO INVEST IN EMMG

1 Growth driven by strong underlying trends

Emerging markets are at the forefront of economic growth, typically generating the highest rates of real GDP growth globally. This growth reflects several long-term secular trends that we expect to continue:

- **Favourable demographics & a rising middle class** – Many emerging market countries have young, growing and increasingly well-educated workforces, along with a fast-growing middle-class.
- **Increasing urbanisation** – The continued growth of the urban middle class helps underpin productivity gains and drive future consumption growth.
- **Disruptive technologies and innovation** - Emerging markets are home to young and increasingly wealthy populations who are harnessing technology faster and more enthusiastically than many of their developed-market peers. Whether it is in e-commerce, fintech, big data, artificial intelligence (AI) or gaming, emerging markets are among the leaders of global innovation.

WHAT IS AN ACTIVE ETF?

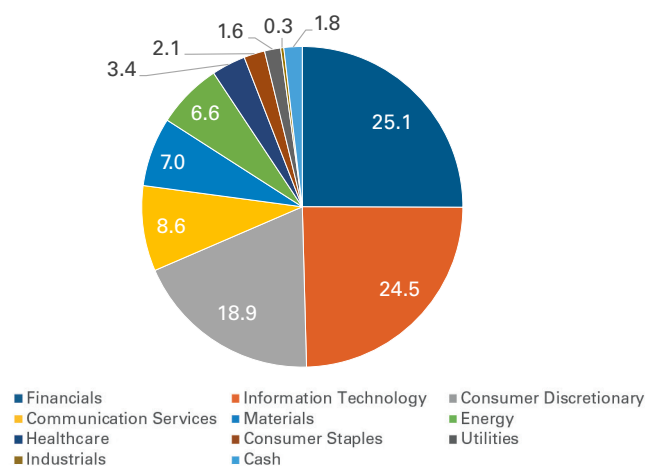
Active ETFs are actively managed investment funds that trade on the Australian Securities Exchange (ASX). The BetaShares Legg Mason Active ETF series allows investors to access Legg Mason’s highly acclaimed and successful investment strategies via a simple trade on the ASX.

Active ETFs have the same legal structure as traditional unlisted managed funds, while additionally providing live intra-day pricing and liquidity. Investors can buy and sell Active ETFs during the trading day via any stockbroker or online broker as they would a share.

2 Access to global leaders in technology and innovation

Emerging markets are at the forefront of the global technology revolution. Many emerging market tech companies are among the most innovative and fastest growing in the world, driven by young, increasingly affluent and tech-savvy populations. The share of information technology stocks in the benchmark MSCI Emerging Markets Index has more than doubled since the start of the decade and has now the largest technology weighting of any major global index.

3 Active stock selection with embedded Environmental, Social and Governance (ESG) analysis

Compared with most developed markets, emerging markets exhibit a significant amount of informational and structural inefficiency. In this environment an active manager can potentially add considerable value over the broad-brush strokes of passive management, with greater scope for identifying mispriced opportunities through proprietary research and fundamental company analysis. In addition, ESG is fully integrated into this investment process, enabling a more thorough understanding of a company’s market position, management quality, long-term business value and the sustainability of future returns.

4 Local company focus

With years of experience assessing and investing in these exciting markets, the Martin Currie Fund Management team has a deep understanding of each local market, including their political, regulatory and social structures. Given the increasing heterogeneity across emerging markets, Martin Currie believes local companies offer better potential for diversification both regionally and at the corporate level.
