# Betashares Private Capital Cliffwater Private Credit Fund

### Objective

The Fund aims to generate attractive income from exposure to a diversified portfolio of loans issued to predominantly US companies, with foreign currency exposure hedged back to the Australian dollar. The Fund invests primarily in the US-domiciled and regulated Cliffwater Corporate Lending Fund (Underlying Fund).

Investors must be comfortable with the risks associated with private credit, including exposure to an asset class that is inherently illiquid and limited ability for investors to withdraw their investment. A minimum investment timeframe of 5 years is suggested.

The Fund provides investors with attractive income, paid quarterly, with exposure to predominantly senior secured, floating-rate loans to healthy businesses. This high-quality loan portfolio historically has demonstrated a high degree of capital stability over time.

Private credit typically has had low correlation to major asset classes. When included as part of a diversified portfolio, private credit has the potential to improve overall returns and lower portfolio level



#### Highly diversified, cost-effective access to private credit

The Fund has exposure to more than 3,800 high-quality middle market loans to predominantly US businesses across a range of industries, avoiding the concentration commonly displayed in singlelender strategies, and provides cost-effective access to this asset class.
