

Betashares Geared Long U.S. Treasury Bond Fund - Currency Hedged (hedge fund)

Objective

GGFD seeks to generate magnified returns that are positively correlated to the returns from 10-year US Treasury Bonds, hedged for currency exposure. The Fund expects to generate a magnified positive return when 10-year US Treasury Bond prices rise (bond yields fall) on a given day, and a magnified negative return when bond prices fall (yields rise) on a given day.

Strategy

GGFD is a geared fund. It invests in cash and cash equivalents and buys 10-year US Treasury Note Futures to obtain a magnified (or geared) exposure. The futures contracts reflect the returns of an underlying US Treasury Bond with 10 years to maturity.

GGFD's portfolio exposure is actively monitored and adjusted to stay within a 2.5x to 3x range on any given day. A 1% rise in the value of the bond on a given day can generally be expected to deliver a 2.5% to 3.0% increase in the value of GGFD (and a corresponding decrease if the value of the bond falls by 1%). GGFD's returns will not necessarily be in the range of 2.5x to 3x over periods longer than a day, due to the effects of rebalancing and compounding of investment returns over time. GGFD does not track a published benchmark.=

Investors in geared strategies should be willing to accept higher levels of investment volatility and potentially large moves (both up and down) in the value of their investment. Gearing magnifies gains and losses and may not be a suitable strategy for all investors. Adjust your interest rate risk
You can use GGFD to make your existing fixed income portfolio less sensitive to movements in interest rates i.e. decrease your interest rate risk.

Leveraged exposure
GGFD gives you the opportunity to make magnified gains when the prices of 10-year US Treasury Bonds rise (bond yields fall) on a given day, as well as the potential for magnified losses when the prices of those bonds fall (bond yields rise).

Capital-efficient
GGFD provides a convenient way to gain geared exposure to 10-year US Treasury Bonds.

Buy and sell on the ASX like any share.

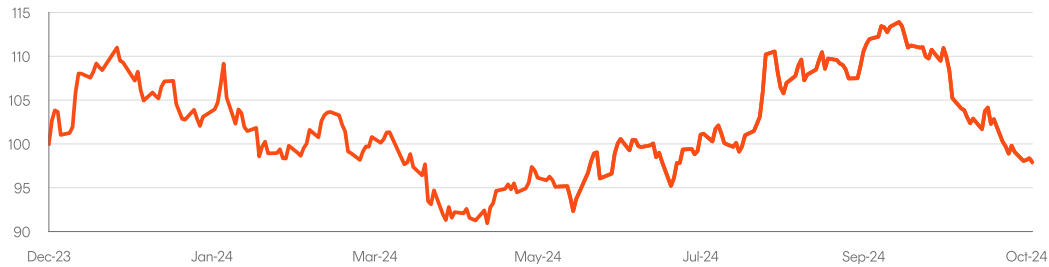
Betashares Geared Long U.S. Treasury Bond Fund - Currency Hedged (hedge fund)
