The responsible entity has made an election for BNDS to be an Attribution Managed Investment Trust (AMIT). The responsible entity considers that BNDS is an AMIT for the income year ended 30 June 2019.

For the purposes of Subdivision 12-H of Schedule 1 of the Taxation Administration Act 1953 (Cth), this distribution includes a 'fund payment' amount of 1.44165 cents per ordinary unit in respect of the income year ended 30 June 2019, calculated as the sum of the following components:

- Other Australian Sourced Income
- Capital Gains Taxable Australian Property – Discounted (multiplied by 2)
- Capital Gains Taxable Australian Property – Indexation method
- Capital Gains Taxable Australian Property – Other method
